The Albuquerque Youth Symphony Program is committed to supporting any student in need of financial assistance for tuition or fees. All families in need of support at any level are encouraged to apply. Assistance is available for expenses associated with program tuition only.

Each application is assessed using a sliding scale of 25-90% of tuition cost, based on HUD Low to Moderate Income (LMI) Guidelines.

Financial aid is awarded for the season, and families must reapply annually. To apply, please fill out this application and return it – along with the requested documents – to AYSP by **Monday, May 21, 2018**. After your request is approved, you will receive an award letter including a payment schedule and commitment from via e-mail the week of **June 11, 2018**.
