

The Albuquerque Youth Symphony Program is committed to supporting any student in need of financial assistance for tuition. All families in need of support at any level are encouraged to apply. Assistance is available for expenses associated with program tuition only.

Each application is accessed using a sliding scale of 25-90% of tuition cost, based on HUD Low to Moderate Income (LMI) Guidelines.

Financial aid is awarded for the season, and families must reapply annually. To apply, please fill out this application and return it – along with the requested documents – to AYSP by **Friday, August 30, 2019**. After your request is approved, you will receive an award letter including a payment schedule and commitment form via e-mail by September 4, 2019.

**\*\* Please note: Incomplete applications are not considered and applications received after August 30, 2019 are not considered. All information provided is confidential.**

**FOR THIS APPLICATION TO BE CONSIDERED COMPLETE**, please be advised of the following:

- This form **must** be accompanied with a copy of the first page of the most recently filed IRS Income Tax Return (1040 or 1040A) and copies of the last two pay stubs for each support of the student. In situations of joint custody, both parents' incomes must be reported.
- Please use a dark permanent marker to conceal any Social Security Numbers listed on all included forms.
- Musician for whom assistance is sought **MUST** be listed as a "Dependent" on line 6c of the included 1040 or 1040A.
